

Privacy Policy

The parties referred to in this policy are **FYB-SE** and You, the User.

FYB-SE is the Owner and Operator of this website listed at the beginning of this Policy. Hereinafter, FYB-SE shall be referred to as “Company”. When first-person pronouns are used in this Policy, (Us, We, Our, Ours, etc.) these provisions are referring to the Company. Additionally, when the terms “the Site” or “Site” are used, these terms refer to the website (<https://www.fybse.se>) listed at the beginning of this Policy, as well as the Services offered via the Site, such as the virtual currency exchange (the “Exchange”) as defined in Our Terms & Conditions.

You, the User – As the User of this Site, this Policy will refer to the User as “You” or through any applicable second-person pronouns, such as “Yours,” etc. Hereinafter, the User of the Site shall be referred to in applicable second-person pronouns.

This Privacy Policy describes how we use information received about You when You visit Our Site or otherwise use Our Services. This Policy does not cover any information that We may receive from or about You through channels other than through the use of the Site or Services.

Amendments to Policy

We reserve the right to revise, amend, or modify this Policy and Our other policies and agreements at any time and in any manner. You should periodically check for any modifications of this Policy by re-visiting this web page. An updated or edited version supersedes any prior versions immediately upon posting. In a merger or acquisition of the Company, customer personal information will likely form part of the assets to be transferred. Any and all changes to this Policy arising from such merger or

acquisition will be posted on the Site.

Information collection

Visitors to Our Site, and users of Our Services, will have multiple manners of interactivity with Us. Depending upon Your level of interaction, We will collect different information about You. The type of information collected is as follows:

Users - Users who interact with Our services in a way which requires registration, for example, participating in the Exchange. As a User, You **SHALL** be prompted to provide a valid email address, Your telephone number and/or if deemed necessary You **MAY** be prompted to provide Your name, Your date and place of birth, Your state-issued ID number, a copy of a valid photo ID (such as a driver's license, passport, armed forces identification card or alien identification card), proof of residence, Your state issued identification number (e.g., Passport number, social security number, employee identification number or taxpayer identification number), other personal information necessary to verify your Identity, Your bank account information, and Your Bitcoin addresses and related information ("personal identification information") which may lead to Your identification.

Guests - Guests are visitors to the Site who never enter into any active data collection pages or use the Services or Exchange. Guests may, however, view content posted by the company. Any information gathered from Guests is also gathered from Users. This information is restricted to cookies, IP Addresses and Referral URLs, and other passive information gathering devices. Guests are also considered Users of the Site.

Non-Personal Information – We use cookies to gather information about You in order to enhance Your experience on the Site. The

information collected in Our cookies includes, but is not limited to, Your User IP address, geographic location and other session data. Cookies are small text files that are stored in Your local browser cache. Such cookies enable the recognition of Your browser in order to optimise the Site and simplify its use. Most browsers are set-up to accept these cookies automatically. We use cookies to improve Our knowledge of Your use of the Site and hence the efficiency of Your individual use of this Website. Please note that if You do erase or block the cookies, You may not be able to utilise some features on the Site. We shall however not in any way, be held liable for any loss or damage resulting from Your inability to use such features.

Personal Information – We **MAY** collect identifying information from You when You register for an account to use the Services or Exchange and when You use such Services.

Usage of Information

The primary uses for Your information are to provide You with services You have requested and/or paid for, to conduct customer identification and anti-money laundering reviews and compliance and to comply with applicable law. Our Privacy Policy is our personal assurance to our Users that Your personal information remains confidential. We shall only use Your information in accordance with the terms of this Privacy Policy. We shall not sell or rent a list of Our customers, including personal information to third parties. In cases of slander, defamation or fraud, We may at Our own discretion disclose general account information to victims and/or the relevant authorities. Your transactions, bank accounts and other financial information shall not be revealed to anyone, unless absolutely necessary. By accepting the Privacy Policy and Terms & Conditions, via the act of registration, You expressly consent to Our use and disclosure of Your personal information in the manner described in this Privacy Policy.

The Site may contain links to other third party websites which are regulated by their own privacy policies. We are not responsible for the privacy policies of these other third party websites even if You accessed them using links from the Site or were linked to the Site from a third party website. We are not responsible for how third parties use your information, and You should become familiar with such third parties' privacy policies prior to requesting their services. Non-personal and aggregate information, such as that collected passively, is used in order to customise Our marketing efforts or to customise the efficient use of Our Site for an aggregate group of customers.

We generally will use Your information for the purposes for which You specifically provide it, for example, to ensure payment, if applicable. We may also use Your information for market research purposes in the form of aggregate data – in order to increase Your (and other Users') experience according to tracked interests, to analyse and target potential new markets, and for other marketing purposes. Such general information may be shared with third parties to show general service usage but shall not be linked to personally identifiable information.

Data Security

We take the protection of Your personal information very seriously and recognise the need to keep Your personal information registered with the Site secure. Save as expressly provided herein, Your personal information will not be passed on by Us for use by third parties in any form whatsoever unless We have obtained Your consent or are legally required to do so. We will retain control of and responsibility for the use of any personal information You disclose to Us. We take measures to protect the transmission of all sensitive User information. We make all reasonable efforts to ensure the integrity and security of Our network and systems by utilising encrypted software and protective firewalls. All User information is retained in-house for the life of the account and is secured via administrative password protection. Nevertheless, We cannot guarantee that Our security

measures will prevent third-party 'hackers' from illegally obtaining this information. We take all reasonable measures to prevent such breaches of security, but You however acknowledge and agree that communications through the internet is not entirely secure and hence, We are unable to guarantee that Our security is one hundred percent (100%) breach-proof. You assume the risk of such breaches to the extent that they occur despite Our reasonable security measures. Our security procedures shall nevertheless continuously be revised based on new technological developments. Whilst We have security measures in place to protect Your personal information, please do not send any other confidential or proprietary information through E-mail. You should exercise extreme caution when disclosing such confidential or proprietary information in this way. We will not be responsible for any loss or damage arising from disclosure of such confidential or proprietary information that is sent through the Site/E-mail.
